- 1. Please provide the architect or engineer budget on this project. The architects estimate is \$140,000.
- 2. As per the pre-bid meeting with the architect, the full set has 15 or 16 sheets. Please provide rest of the missing sheets to properly bid the project.

  Correct plans have been provided via Addendum 1.
- 3. As per the pre-bid visit walkthrough, amount of work needs to be done, and missing contract document plans to evaluate, there is not enough time to bid the project properly by the 12th of April. I humbly request to extend the bid date to 19th of April, just 1 more week. Please advise.

The City is ameanable and has extended the bid submission deadline to 10:00 a.m. on April 19, 2023.

- 4. Please provide complete specifications for the vanities and countertops.

- 5. Please provide complete specifications and measurements for the toilet partitions, such as doors, panels and pilasters.
  - GC shall be responsible to maintain all code compliance clearances and dimensions as required (standard size and ADA sizes). 6. Please if ceiling lights need to get changed. If yes, please provide all specifications, such as manufacturers and model #s.

- Please provide exact locations for all toilet accessories.

- 12. The finishes specifications show ACT1, however, it does not show any symbol or note on the floor plan. Please confirm there is no ceiling work. GC IS LOOKING AT WRONG PLANS; PLEASE REFER TO PLANS PROVIDED IN ADDENDUM 1.
- 13. Note #4 on A1.00 and A2.00 indicates to provide new mecho shades at all exterior windows, however floor plan does not show these windows. Please confirm there is no mecho shade scope of work.

- 14. Note #3 indicates all exterior walls shall be painted with P-1 without exception. Please confirm if any exterior wall is to be painted.
